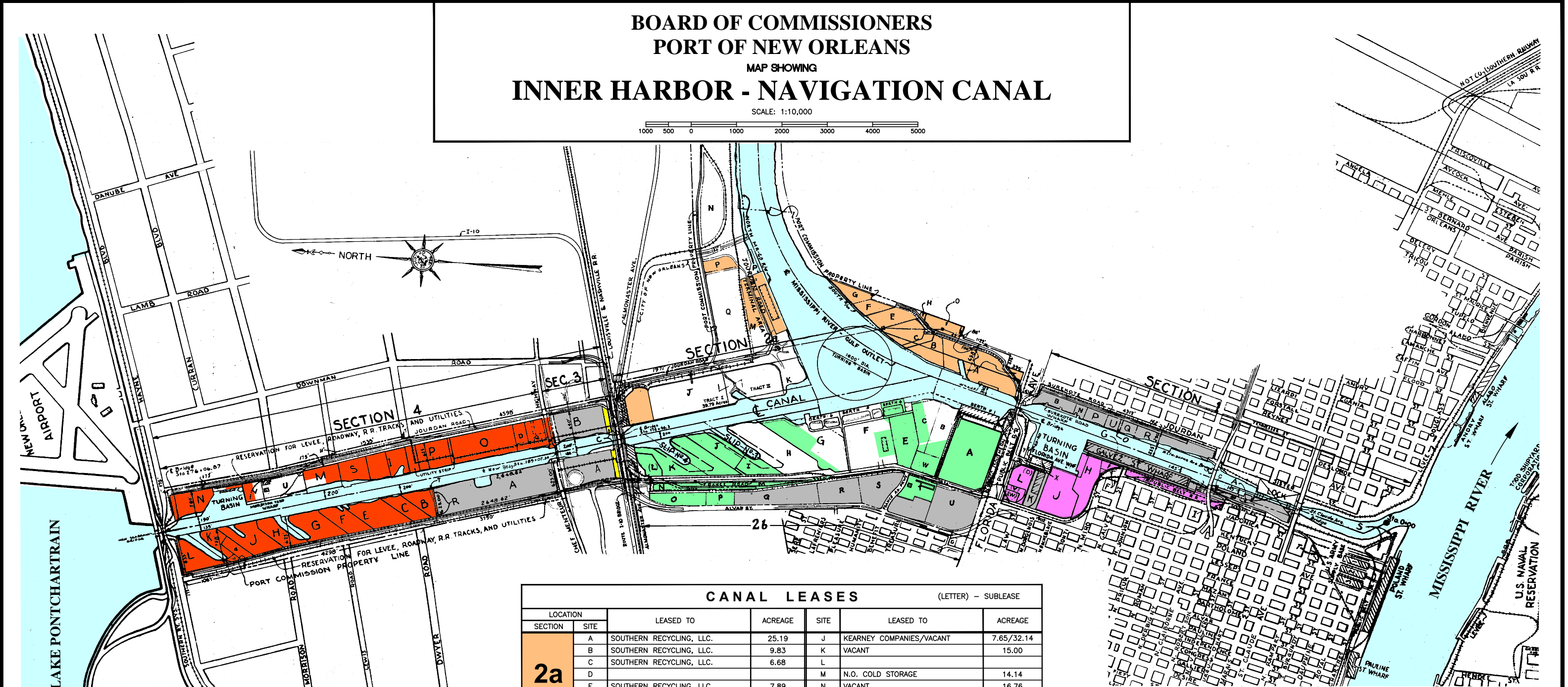
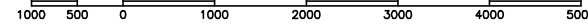


BOARD OF COMMISSIONERS PORT OF NEW ORLEANS
